1 Ms Dholkia states that the proposed respondent in this interim

application is Google India Private Limited, whereas it should be Google LLC, a company operating under the laws of Delaware, having its office address at 1600 Amphithatre Parkway, Mountain View, CA 94043.

If such an application is filed, the TDSAT may consider the same on its own merits (we are not expressing any opinion) and dispose the same expeditiously.
- 4 In view of the above, Interim Application No.1357 of 2021 stands disposed.
